## **PROCEEDINGS OF 6<sup>th</sup> ANNUAL GENERAL MEETING OF THE COMPANY**

### **1. Date, Time & Venue of the Meeting:**

The 6<sup>th</sup> Annual General Meeting (hereinafter referred to as the 'AGM') of Sayaji Hotels (Indore) Limited was held on Monday, 24<sup>th</sup> Day of June, 2024 at 03:00 P.M. (IST) through Video Conference (VC) / Other Audio Visual Means (OAVM). The meeting was held in compliance with the General Circulars dated April 8, 2020, April 13, 2020, May 5, 2020, January 13, 2021, December 14, 2021, December 28, 2022 and September 25, 2023 (collectively referred to as MCA Circulars) issued by the Ministry of Corporate Affairs ("MCA") and Circulars dated May 12, 2020, January 15, 2021, May 13, 2022, January 5, 2023 and October 7, 2023 (SEBI Circulars) issued by the Securities and Exchange Board of India ("SEBI") and as per the applicable provisions of the Companies Act, 2013 and the Rules made thereunder.

- The Chairman continued his speech by giving an overview of the operations and the financial performance of the Company during FY 2023-24 and Company's future outlook and expansion plans.
- The Chairman concluded his speech by placing on record his appreciation towards employees of the Company for their continuous contribution in the growth of the Company and by assuring all the stakeholders to emerge as stronger in coming time.
